HCPF owns directly 2,925,456 shares of common stock and pursuant to a Warrant issued August 11, 2014 a right to immediately acquire 976,450* (subject to adjustment as set forth in the Warrant) shares of common stock at an exercise price of \$0.45 (subject to adjustment as set forth in the Warrant) per share. By reason of the provisions of Rule 13d-3 of the Act, each of the Reporting Persons may be deemed to beneficially own 3,901,906* shares of the Issuer's common stock.
